An Office Memorandum 12-2/2014-AR dated 6.5.2016 has been received from Government of India, Ministry of Human Resource Development, Department of Higher Education, New Delhi on the subject mentioned above the undersigned is directed to inform that the UGC has issued a circular to all Universities to furnish the action taker report vide our letter No. 1-4/2007(SCT) dated 19.8.2009, this is reference to the Commission decision at 460<sup>th</sup> meeting held on 22<sup>nd</sup> June 2009 & ratified the decision that all the Colleges/Institutes which are receiving grant-in-aid from the public fund and developed their infrastructure i.e. land, building, class rooms, libraries, laboratories etc from the public fund/grant and now running Professional Courses in the pattern of Self-financing /un-aided and not providing reservation to SC/ST candidates/students in the admission to these courses, may be asked to provide reservation to SC/ST candidates/students in all such Professional Courses on the Government pattern i.e. subsidized fees.



Sub - Non-implementation of SC/ST Reservation policy of the Govt. In the matter of admission to the Professional Courses by the Universities and Colleges/Institutes - regarding.

Sir  
The University Grants Commission has received representations stating that the Universities and Colleges/Institutes are not following the SC/ST Reservation Policy of the Govt. in the matter of admission to the Professional courses.

The UGC Standing Committee on SC/ST at its meeting held on 20<sup>th</sup> January, 2009 discussed the above matter in the light of UGC norms/guidelines and resolved that in all aided and unaided institutions reservation should be implemented in self-financing professional courses for the SC/ST candidates. Fees if any, required to be paid by SC/ST students should be paid to the institutions by the Government. Under no circumstances, the SG/ST candidates seeking admission to professional courses should charged fees in any form.

The above decision of the UGC Standing Committee on SC/ST was also reported to the Commission at its 460<sup>th</sup> meeting held on 22<sup>nd</sup> June, 2009. The Commission ratified the above decision.

You are therefore, requested that all the Colleges/Institutes, which are receiving grant-in-aid from the public/fund and developed their infrastructure i.e land, building, class rooms, libraries, laboratories etc from the public fund/grant and now running Professional courses in the pattern of Self-financing/un-aided and not providing reservation to SC/ST candidates/students in the admission to these courses, may be asked to provide reservation to SC/ST candidates/students in all such Professional Courses on the Government pattern i.e set aside rates/fees.

An early action in the matter will be highly appreciated. An action taken report may also be sent to UGC at an early date.
