As you are aware the University Grants Commission has notified "UGC Regulations on curbing the meriace of ragging In higher educational Institutions, 2009" in order to prohibit, prevent and eliminate the scourge of ragging. These Regulations are mandatory and all institutions are required to take necessary steps for its implementation in toto, including the monitoring mechanisms as per provisions in the Regulations and ensure its strict compliance. Any violation of these Regulations will be viewed seriously. If any institution fails to take adequate steps to prevent ragging or does not act in accordance with these Regulations or fails to punish perpetrators of incidents of ragging suitably, it will attract punitive action against itself by UGC.

In this regard, please find enclosed herewith copy of a letter from the Secretary, UGC which is self-explanatory in the matter. You are requested to take all necessary steps for the implementation of these Regulations and also direct the colleges affiliated to your university for strict compliance of these Regulations, by circulating the letter of Secretary, UGC to all the affiliated Colleges

You are also requested to instruct the institutions to submit the online compliance of antiragging Regulations on curbing the menace of ragging in higher educational institutions, 2009 at www.antiragging.in

As per provisions in the above Regulations and ensure its strict compliance. Any cadation of these regulations will be viewed seriously. If any institution fails to take adequate steps to prevent ragging or does not act in accordance with these Regulations or fails to punish perpetrators of incidents of ragging saitably, it will attract punitive action against itself by UGC.

All Universities Institute as are requested to step up anti-ragging mechanism by way of adequate publicit. Through various mediums, constitution of anti-ragging committee and anti-ragging squad, setting up of Anti-Ragging Cell, installing CCTV cameras at vital points, alarm bells etc. Regular interaction and counseling with the students, identification of trouble-triggers, mention of Anti-ragging warning in the institution's prospectus and information booklets brochures shall be ensured. Surprise inspection of bastels students accommodation, canteens, rest cum recreational rooms, toilets, but stands and any other measure which would augur well in preventing/quelling ragging and any uncalled for behavior/incident shall be under taken. The students and the parent/guardian community may also be made aware of the anti-ragging helpting, anti-ragging website, anti-ragging monitoring agency. All Universities: Colleges/Institutions should take necessary steps for its implementation under intimation to the UGC. The Institutions are also requested to take legal action in scriptis (#888), involving local police authorities.
